## 1. Any SEVERE SYMPTOMS after suspected sting: **Treatment**: One or more of the following: LUNG: Short of breath, wheeze, repetitive cough 1. INJECT EPINEPHRINE IMMEDIATELY HEART: Pale, blue, faint, weak pulse, dizzy, confused 2. Call 911 THROAT: Tight, hoarse, trouble breathing/swallowing 3. Begin Monitoring 4. Give additional medications (if ordered) MOUTH: Obstructive swelling (tongue and/or lips) SKIN: Many hives over body a. Antihistamine Or combination of symptoms from different body areas: b. Inhaler (bronchodilator) if asthma SKIN: Hives, itchy rashes, swelling (e.g., eyes, lips) GUT: Vomiting, diarrhea, crampy pain 2. MILD SYMPTOMS ONLY: **Treatment:** 1. GIVE ANTIHISTAMINE MOUTH: Itchy mouth SKIN: A few hives around mouth/face, mild itch 2.. If symptoms progress (see above), USE **EPINEPHRINE** GUT: Mild nausea/discomfort 3. Begin monitoring Medications/Doses Epinephrine (brand and dose): Antihistamine (brand and dose): Other (e.g., inhaler-bronchodilator if asthmatic): This plan is subject to change but only with documentation from physician along with meeting with parents and staff. This plan will be shared with all teachers, support staff and transportation that are involved with student's school day.
